DURING 2012, SEVERAL ORGANIZATIONS UTILIZED THE PROGRAMS AND INCENTIVES OF THE CAIDA, RESULTING IN APPROXIMATELY \$30.9 MILLION OF NEW PROJECTS WITHIN THE CITY OF ALBANY. THESE PROJECTS ARE ANTICIPATED TO CREATE OR RETAIN APPROXIMATELY 550 JOBS WITHIN THE CITY OF ALBANY. THREE LOANS WITH A TOTAL VALUE OF \$900,000 WERE DISBURSED IN 2012 FROM THE REAL ESTATE LOAN FUND ESTABLISHED IN 2010. DURING 2012, TWO PROJECTS RECEIVED \$300,000 UNDER THE DOWNTOWN ALBANY RESIDENTIAL CONVERSION AND COMMERCIAL REHABILITATION PROGRAM, FUNDED BY NY MAIN STREET GRANT FUNDS.
