CAPITALIZE ALBANY CORPORATION (THE "CORPORATION") ADMINISTERS AND PROVIDES STAFFING, OFFICE EQUIPMENT, PHONE AND COMPUTER NETWORK SUPPORT TO THE CITY OF ALBANY INDUSTRIAL DEVELOPMENT AGENCY (CAIDA) AND THE CITY OF ALBANY CAPITAL RESOURCE CORPORATION (CACRC). DURING 2016, SEVERAL ORGANIZATIONS UTILIZED THE PROGRAMS AND INCENTIVES OF CAIDA; THE APPROVAL OF THE PROJECTS WILL RESULT IN OVER \$100 MILLION OF INVESTMENT WITHIN THE CITY OF ALBANY.
