CAPITALIZE ALBANY CORPORATION (THE "CORPORATION") ADMINISTERS AND PROVIDES STAFFING, OFFICE EQUIPMENT, PHONE AND COMPUTER NETWORK SUPPORT TO THE CITY OF ALBANY INDUSTRIAL DEVELOPMENT AGENCY (CAIDA) AND THE CITY OF ALBANY CAPITAL RESOURCE CORPORATION (CACRC). DURING 2018, SEVERAL ORGANIZATIONS UTILIZED THE PROGRAMS AND INCENTIVES OF CAIDA. THE APPROVAL OF THE PROJECTS WILL RESULT IN OVER \$280 MILLION OF INVESTMENT WITHIN THE CITY OF ALBANY. THESE PROJECTS ARE ANTICIPATED TO CREATE OR RETAIN NEARLY 865 TEMPORARY AND PERMANENT JOBS WITHIN THE CITY AND CREATE MORE THAN 725 UNITS OF BOTH AFFORDABLE AND MARKET-RATE HOUSING.
