Review of the minutes from the Liberty Park Committee meeting of July 31, 2018

The Committee reviewed the minutes of the meeting. Susan Pedo made a motion for approval, and John Harris seconded. The Committee agreed unanimously to approve the minutes from the Finance & Investment Committee meeting of July 31, 2018.

Progress Update

Committee Chair, Sarah Reginelli, provided an update for the Committee of progress by Staff to date on the proposed Liberty Park transaction. The presentation included a site overview and summary of property acquisition for the upcoming timeline. Counsel advised the Committee of their active efforts in communication with the outside parties for anticipation of reaching agreements in the near future. The Corporation is committed to obtaining site control in summer of 2019 and will remain in active communication with the outside parties.

Counsel discussed the terms of the potential property transfer including simply a change in ownership having no direct environmental impacts as defined by SEQR.
